1. Except as provided in Paragraph 3 herein the signature of Carrier's driver on any bill of lading other than the Carrier's bill of lading will act only to acknowledge the receipt of freight as described on the document. This signature will not acknowledge agreement to any terms and conditions of carriage and/or liability conditions that may also appear on the document. Terms and conditions of STYH100 Rules Tariff and the bill of lading contract will apply.

2. Continued use of unauthorized bills of lading by Shipper will not, and does not, constitute an implied acceptance or ratification by Carrier.

3. When the Shipper fails to state the freight terms (prepaid or collect) in writing on the bill of lading, the shipment will move as prepaid and all applicable charges will be borne by the Shipper.

4. Shipper may furnish and use its own formatted bills of lading if such bills of lading contain such information as identification and location of the consignor and consignee, commodity descriptions and other information pertinent to the shipment. The name and address of only one consignor and one consignee must be shown on the bill of lading. Commodity word descriptions must be used and must conform to those in the applicable tariff or classification; however, appropriate, understandable, abbreviated descriptions may be used if the governing classification item numbers and appropriate sub numbers are also shown. The number of articles, packages or pieces and the kind of packages must be shown. The weight, volume or measurement of the articles must be shown if the applicable rates or charges are based on such units of weight, volume or measurement.

5. When a corrected bill of lading or letter of authority to amend any aspect of a bill of lading is received from the responsible party, either Shipper, Consignee or third party, the following provisions will apply:

- A. Corrected bills of lading or letters of authority to change the payment status from collect to prepaid or prepaid to collect will be subject to the acceptance of the Carrier.
- B. Corrected bills of lading or letters of authority to change the freight charge collection status from prepaid to collect will not be accepted if Section 7 of the corrected bill of lading has been signed by the Shipper, or once the shipment has been delivered, or if shipment has been lost or damaged.
- C. Corrected bills of lading or letters of authority to change the actual or released value of a commodity will not be accepted after the shipment has been delivered.
- D. Changes in commodity description, weight or pieces shall be accompanied by satisfactory written documentation, such as original invoice or descriptive advertising copy.

6. When Payor of freight or other lawful charges requires or requests that any of the following documents be submitted with freight bills, or statements of charges, as a prerequisite to payment, a charge of (BELOW) will apply for each such document requested (see Note A):

- A. Any part of the original bill of lading sets or copies thereof, other than one Shipper-furnished copy. When the Shipper-furnished copy of bill of lading is to be returned, it must be clearly and prominently marked by the Shipper with specific instructions directing its return with freight bill.
- B. More than one original freight bill and one copy per shipment, or more than one original and one copy of the Carrier's statement of transportation charges.
- C. Any forms or copies of forms other than those described in (A) or (B) above.
- D. Information not shown on the bill of lading or shipping order at time of Shipment.
- E. Proof of delivery.
